## ELIGIBILITY

The tournament is open to the first 200 paid male golfers holding a regular golf memberships in good standing in one of the member clubs of the EDGA OR meet the residency requirement to compete in this event AND who have reached their Fiftieth (50) birthday by August 18, 2011.

YOU MUST HAVE BEEN BORN ON OR BEFORE AUGUST 18, 1961 TO PARTICIPATE IN THIS EVENT.

## ENTRY FEE

The entry fee is \$50.00 and must accompany this entry form. No refunds will be granted for cancellations received after the entry closing date. Entry applications must be completed fully and signed by the applicant and attested to (as to USGA Index and member club membership) by the club professional or owner/manager. Entries will only be received by mail and must be RECEIVED no later than the entry close date. The EDGA is not responsible for mail that is lost or delayed. No entries will be accepted by telephone. Entries close Monday, August 8, 2011.



If you are not a member of an EDGA member club and meet the residency requirement, you must pay a non-member fee of \$60.00 to compete in this event.

## LATE ENTRIES

All entries received after Monday, August 8, 2011 will only be accepted subject to the approval and discretion of the tournament chairman based on availability and other factors. A late entry fee in the amount of \$20.00 must accompany a late entry for it to be considered for acceptance.

## PAIRINGS & TEE TIMES

Pairings and tee times will be determined by the tournament chairman and/or his committee. Contestants will be notified via the website (which is the official notification) and the newspaper as to their starting time in the event. A contestant who fails to appear promptly at the tee when scheduled to begin play and who has not canceled his entry by notification of the secretary, tournament director or his committee may be subject to disqualification for this event and subsequent events of the Association.

## RULES

Except in the case of special rules posted by the tournament chairman, the tournament will be governed by the Rules of Golf as promulgated by the USGA. The use of power golf carts will be permitted for this event.

## DRESS CODE

Proper attire is required. Players are required to dress in good taste. Clothing that has been deemed inappropriate includes tank tops, t-shirts, blue jeans, short shorts (those not specifically tailored for golf wear), and cut-offs. Participants wearing items that are considered inappropriate by the tournament chairman will not be permitted to participate in the event.

## EVENT DETAILS

The tournament will be played over 18 holes of stroke play. There will be both scratch and handicap divisions for overall scores and within 5 age groups. In the event of a tie for the overall scratch championship, a sudden-death playoff will be held. If, due to inclement weather or extenuating circumstances this is not practicable, co-champions will be named. In the event of inclement weather during the competition, a round will stand if more than Fifty-percent (50%) of the field completes play. In the event that the entire round is canceled, every effort will be made to obtain an alternate date. If this is not possible the tournament will not be conducted in the current year.

## AGE GROUPS

To facilitate the awarding of prizes, the following age groupings will be used:  
50-54 - 55-59 - 60-64 - 65-69 - 70 & Over.

## PRIZES

Trophies will be awarded to the players returning the lowest gross and net scores for 18 holes. The overall scratch champion will also have his name engraved onto the permanent Joseph C. Martin memorial trophy. Additional prizes, including overall scratch and handicap runners-up will be awarded and others as determined by the tournament chairman.
